## **UNIFICATION OF BOWLS NSW AND WOMEN'S BOWLS NSW**

Ballots of members of both Bowls NSW and Women's Bowls NSW were conducted online during the period 7 May to midnight on 30 May 2021.

### **For Bowls NSW**

Each club held a Special General Meeting to vote on the resolutions. The results of each club's votes were transmitted to their respective Zone Secretary or Delegate who tallied the votes from all clubs in their Zone and then reported that resulted online to Elections Australia. In addition to the 16 Zones, the 7 Bowls NSW Directors were each also entitled to a vote bringing the total number of potential votes to 23.

Resolution A read :- *That the constitution of the Royal NSW Bowling Association Limited (RNSWBA) be amended and replaced with the Constitution marked with the letter "A"*

Votes in favour of Resolution A ..... 23

Votes opposed to Resolution A ..... 0

Total Votes Submitted ..... 23

Accordingly, Resolution A is passed by a 100% majority.

Resolution B read :- *If Special Resolution A is approved, That the Boards of RNSWBA and the New Bowls Entity be authorised to take all necessary steps to effect resolution A above.*

Votes in favour of Resolution B ..... 23

Votes opposed to Resolution B ..... 0

Total Votes Submitted ..... 23

Accordingly, Resolution B is passed by a 100% majority.

### **For Women's Bowls NSW**

Each club held a Special General Meeting to vote on the resolutions. Each club then directly sent their result online to Elections Australia. A total of 335 clubs registered to vote.

Resolution A read :- *That the constitution of the New South Wales Women's Bowling Association Inc. be amended and replaced with the Constitution marked with the letter "A"*

Votes in favour of Resolution A ..... 314

Votes opposed to Resolution A ..... 3

Total Votes Submitted ..... 317

Accordingly, Resolution A is passed by a 99.05% majority.

Resolution B read :- *If Special Resolution A is approved, That the Boards of WENSW and the New Bowls Entity be authorised to take all necessary steps to effect resolution A above.*

Votes in favour of Resolution B ..... 314

Votes opposed to Resolution B ..... 3

Total Votes Submitted ..... 317

Accordingly, Resolution B is passed by a 99.05% majority.

While the changes might not be noticeable just yet, the new Board and staff have been working hard throughout the last few months as we look towards the merging of the two offices and various areas of the sport as we build on the momentum and enthusiasm brought on by unification.

The Unification Roadshow took us to many clubs and places throughout NSW, and I would like to personally thank all the members that we met along the way for their valuable insights and their willingness to ask questions. Also, a huge thanks to both sets of staff in the Mascot and Pitt Street offices for their efforts during the Unification Roadshow while both CEOs were out of office.

While some events were unable to be completed, we thank the host venues of Asquith, Merrylands, Guildford, Club Malua, Tomakin and Tuncurry Beach Bowling Club for their support. A special mention to the staff and volunteers of Club Malua, who despite having no permanent club house managed to host an extremely enjoyable and successful State Championships.

As you will see in our financial statements while we have ended the year on a profit the majority of this has come through COVID 19 relief and government grants. Discounts were offered to all our member clubs, and with the cancellation and postponement of our State Events this has made a difference to our bottom line.



On a personal note, a sincere thank you to the Board, staff and all the Committee Members for their support over the last 12 months. While it has certainly been a challenging time across the sport, the commitment shown by all can be seen through the progressive and transparent nature of the unification process.

This coming year members will hopefully start to see the many benefits of unification as Bowls New South Wales Ltd continue their focus on club health and development with a more aligned, cohesive, and inclusive strategy.

## GOVERNANCE COMMITTEE

We faced new challenges and changes during the year, two major ones being the pandemic and Unification.

The duties of the Governance Committee largely focus on examining and maintaining the Constitutions and By-Laws at all levels of the State Association. It also assists members to interpret and implement those documents, policies and procedures. Our aim is to equip our members with good governance knowledge, skills and tools.

We are not a 'stand-alone' organisation but govern within and alongside the Bowls Australia (BA), Sport Australia (SA) and Sport NSW structures.

Our goals for last year were to have more efficient governance at all levels of the association; improve communication with members; be relatable to members and listen to positive ideas about the future for bowls in NSW.

We contributed to the BNSW/WBNSW Unification Working Group, achieving unification and creating a constitution for the new entity to provide the direction for a healthier bowling organisation in NSW.

Clubs are clearly familiar with the 2017 Constitutions and By-Laws, evidenced by a huge drop in the number of queries regarding implementation and related procedures.

There was an improvement in succession planning, mentoring and empowering others to take on positions, evidenced by fewer enquiries this year from clubs about vacancies on committees. Volunteer officers are encouraged to actively support the growth of their club by ensuring there is always someone ready and willing to step up when required. This requires, among other things, empowerment and mentoring so people will feel supported and confident to assist.

There was a decrease in the number of discipline and member protection issues reported to the Committee. This suggests members are more aware of the fact that laws in our society regarding unacceptable behaviour also apply to our conduct in the bowling club and on the greens. WBNSW has a 'zero tolerance' attitude towards discrimination, bullying and/or harassment in any form or in any situation. We have Member Protection Information Officers available to assist members if required.

Our goals for next year are to work with the interim board and staff towards more efficient governance at all levels of the association; work with clubs to adapt and alter constitutions, policies, and procedures to accommodate any desired changes due to unification; respond to members with

governance issues and respond to positive ideas about the governance of bowls in NSW. All these goals aim to improve the growth and running of the sport.

The Governance Committee would like to acknowledge the contribution of volunteers at all levels in all areas of the sport. Our volunteer officers now have a good working knowledge of Standing Orders appropriate to the management of clubs. They have adapted exceptionally well to the changes required due to the pandemic and are to be commended for their patience and tolerance.

Volunteers not only maintain a club but allow a club to flourish. Volunteers don't always have a title, yet often these people set the tone of the club and can make others feel welcome, thereby growing the sport. Can you make a contribution to the life of the club as a committee member, official or helper when needed? Your contribution will create change, because you bring fresh eyes and ideas. At the same time, you will gain new skills and a sense of well-being.

If you would like to be a positive part of the next year of change, consider joining the Governance Committee.

The Committee encourages all members to take part in the many training courses available in order to gain a better understanding and greater enjoyment of the sport.

To all volunteers, including those who volunteer regularly but don't have a title, staff and members who have interacted with the Governance Committee this year: Thank you - you are greatly appreciated.

Thanks go to Sue Thurley who joined the Governance Committee this year. I hope it was educational and rewarding

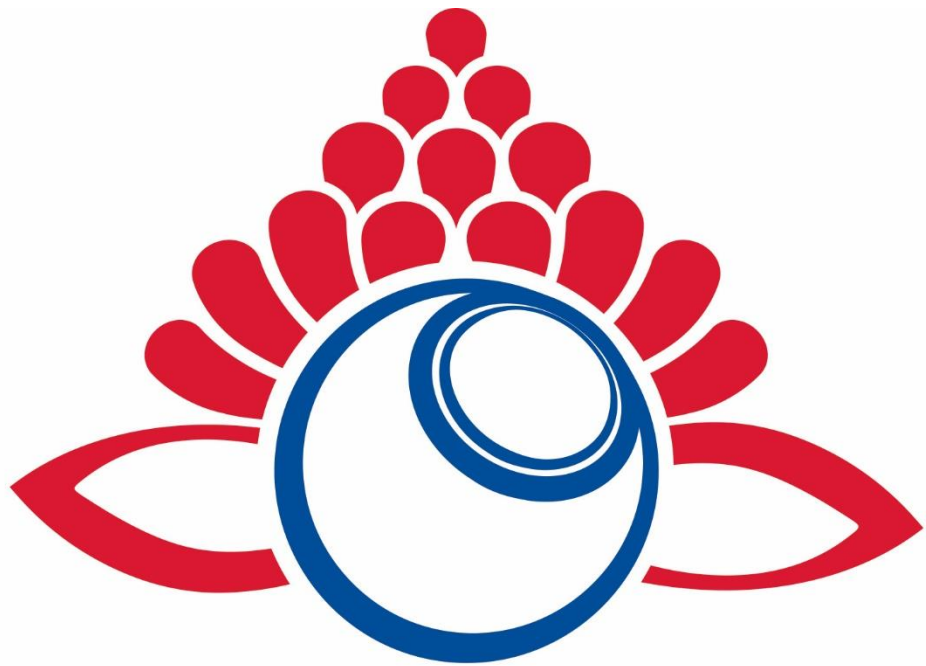

**NOTE 1 - SUMMARY SIGNIFICANT ACCOUNTING POLICIES**

**Reporting entity**

New South Wales Women's Bowling Association is an incorporated association and domiciled in Australia. The financial statements of the Association are as at and for the year ended 30 June 2021.

The Association is a not-for-profit entity and is primarily involved in the operation and promotion of Women's Bowls.

**Basis of Preparation**

New South Wales Women's Bowling Association Inc. applies Australian Accounting Standards – Reduced Disclosure Requirements as set out in AASB 1053 : *Application of Tiers of Australian Accounting Standards* . The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards – Reduced Disclosure Requirements of the Australian Accounting Standards Board (AASB) and the *Associations Incorporation Act New South Wales 2009*. The association is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in financial statements containing relevant and reliable information about transactions, events and conditions. Material accounting policies adopted in the preparation of the financial statements are presented below and have been consistently applied unless stated otherwise.

The financial statements, except for the cash flow information, have been prepared on an accrual basis and are based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

**Income Tax**

The Association has been advised by the Australian Taxation Office that it is exempt from income tax.

**Property, Plant and Equipment**

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment losses.

Property, plant and equipment are measured on the cost basis less depreciation and impairment losses. The carrying amount of property, plant and equipment is reviewed annually by the Association to ensure it is not in excess of the recoverable amount from those assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets' employment and subsequent disposal. The expected net cash flows have not been discounted to their present values in determining recoverable amounts.

The cost of fixed assets constructed within the Association includes the cost of materials, direct labour, borrowing costs and an appropriate proportion of fixed and variable overheads.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Association and the cost of the item can be measured reliably. All other repairs and maintenance are charged to the statement of comprehensive income during the financial period in which they are incurred.

**Depreciation**

The depreciable amount of all fixed assets, including buildings and capitalised lease assets, but excluding freehold land, is depreciated on a straight line basis over their useful lives to the Association commencing from the time the asset is held ready for use.

The depreciation rates used for each class of depreciable assets are:

Buildings	2.5%
Plant and equipment	20% - 40%

The assets' residual values and useful lives are reviewed and adjusted, if appropriate, at each balance date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains and losses are included in the statement of comprehensive income. When revalued assets are sold, amounts included in the revaluation relating to that asset are transferred to retained earnings.

**Impairment of Assets**

Non-financial assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount.

Recoverable amount is the higher of an asset's fair value less costs of disposal and value-in-use. The value-in-use is the present value of the estimated future cash flows relating to the asset using a pre-tax discount rate specific to the asset or cash-generating unit to which the asset belongs. Assets that do not have independent cash flows are grouped together to form a cash-generating unit.

**Cash and Cash Equivalents**

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities on the statement of financial position.

**Employee Benefits**

Provision is made for the Association's liability for employee benefits arising from services rendered by employees to balance date. Employee benefits arising from annual leave and long service leave have been measured at their nominal amount.

Contributions are made by the Association to employee superannuation funds and are charged as expenses when incurred.

**Revenue**

Non-reciprocal grant revenue is recognised in the statement of comprehensive income when the Association obtains control of the grant and it is probable that the economic benefits gained from the grant will flow to the Association and the amount of the grant can be measured reliably.

If conditions are attached to the grant which must be satisfied before it is eligible to receive the contribution, the recognition of the grant as revenue will be deferred until those conditions are satisfied.

When grant revenue is received whereby the Association incurs an obligation to deliver economic value directly back to the contributor, this is considered a reciprocal transaction and the grant revenue is recognised in the statement of financial position as a liability until the service has been delivered to the contributor, otherwise the grant is recognised as income on receipt.

The Association receives non-reciprocal contributions of assets from the government and other parties for zero or a nominal value. These assets are recognised at fair value on the date of acquisition in the statement of financial position, with a corresponding amount of income recognised in the statement of comprehensive income.

Revenue from the sale of goods is recognised upon the delivery of the goods to customers.

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets. Revenue from the rendering of a service is recognised upon the delivery of the service to the customers.

All revenue is stated net of the amount of goods and services tax (GST).

**Donations**

Donations are recognised when received.

**Goods and Services Tax (GST)**

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the statement of financial position are shown exclusive of GST.

Cash flows are presented in the statement of cash flows on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

**Leases**

At inception of a contract, the entity assesses if the contract contains or is a lease. If there is a lease present, a right-of-use asset and a corresponding lease liability is recognised by the entity where the entity is a lessee. However all contracts that are classified as short-term leases (lease with remaining lease term of 12 months or less) and leases of low-value assets are recognised as an operating expense on a straight-line basis over the term of the lease. Initially the lease liability is measured at the present value of the lease payments still to be paid at the commencement date. The lease payments are discounted at the interest rate implicit in the lease. If this rate cannot be readily determined, the entity uses the incremental borrowing rate.

Lease payments included in the measurement of the lease liability are as follows:

- fixed lease payments less any lease incentives;
- variable lease payments that depend on an index or rate, initially measured using the index or rate at the commencement date;
- the amount expected to be payable by the lessee under residual value guarantees;
- the exercise price of purchase options, if the lessee is reasonably certain to exercise the options;
- lease payments under extension options, if the lessee is reasonably certain to exercise the options; and
- payments of penalties for terminating the lease, if the lease term reflects the exercise of an option to terminate the lease.

The right-of-use assets comprise the initial measurement of the corresponding lease liability as mentioned above, any lease payments made at or before the commencement date, as well as any initial direct costs. The subsequent measurement of the right-of-use assets is at cost less accumulated depreciation and impairment losses.

Right-of-use assets are depreciated over the lease term or useful life of the underlying asset, whichever is the shortest.

Where a lease transfers ownership of the underlying asset or the cost of the right-of-use asset reflects that the entity anticipates to exercise a purchase option, the specific asset is depreciated over the useful life of the underlying asset.

**Current and non-current classification**

Assets and liabilities are presented in the statement of financial position based on current and non-current classification.

An asset is classified as current when: it is either expected to be realised or intended to be sold or consumed in the association's normal operating cycle; it is held primarily for the purpose of trading; it is expected to be realised within 12 months after the reporting period; or the asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period. All other assets are classified as non-current.

A liability is classified as current when: it is either expected to be settled in the association's normal operating cycle; it is held primarily for the purpose of trading; it is due to be settled within 12 months after the reporting period; or there is no unconditional right to defer the settlement of the liability for at least 12 months after the reporting period. All other liabilities are classified as non-current.

Deferred tax assets and liabilities are always classified as non-current.

**Comparative Figures**

Where required by Accounting Standards comparative figures have been adjusted to conform with changes in presentation for the current financial year.

**Critical Accounting Estimates and Judgments**

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgements and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgements, estimates and assumptions on historical experience and on other various factors, including expectations of future events, management believes to be reasonable under the circumstances. The resulting accounting judgements and estimates will seldom equal the related actual results. The judgements, estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities (refer to the respective notes) within the next financial year are discussed below.

*Estimation of useful lives of assets*

The association determines the estimated useful lives and related depreciation and amortisation charges for its property, plant and equipment and finite life intangible assets. The useful lives could change significantly as a result of technical innovations or some other event. The depreciation and amortisation charge will increase where the useful lives are less than previously estimated lives, or technically obsolete or non-strategic assets that have been abandoned or sold will be written off or written down.

*Impairment of non-financial assets other than goodwill and other indefinite life intangible assets*

The association assesses impairment of non-financial assets other than goodwill and other indefinite life intangible assets at each reporting date by evaluating conditions specific to the company and to the particular asset that may lead to impairment. If an impairment trigger exists, the recoverable amount of the asset is determined. This involves fair value less costs of disposal or value-in-use calculations, which incorporate a number of key estimates and assumptions.

**The notes to the financial statements**

The notes present information that is relevant to an understanding of the material items contained in the financial statements. The notes give prominence to areas of the associations activities that are considered to be most relevant to an understanding of the statement of financial position and the profit or loss and other comprehensive income and statement of changes in equity and cashflows and are cross referenced to those statements.
