Champion of Club Champions



1. Introduction and Scope

All events shall be conducted in line with the Laws of the Sport of Bowls and with the Bowls NSW General Conditions of Play.

These Conditions of Play provide specific Conditions relative to Champion of Club Champions.

2. Event Name

Champion of Club Champions

3. Competitions

Bowls NSW Champion of Club Champions shall be conducted as single gender competitions:

- Men's Champion of Club Champions Singles
- Men's Champion of Club Champions Pairs
- Women's Champion of Club Champions Singles
- Women's Champion of Club Champions Pairs

4. Number of Bowls used & Duration of Matches

4.1. Singles:

4 bowls per player, 25 shots up (shots in excess of 25 do not count)

4.2. Pairs

4 bowls per player in the order lead 2 bowls, skip 2 bowls and repeat.

Matches shall be played over 21 ends.

Where 3 sectional matches are played in a day, matches shall be played over 15 ends.

5. Eligibility

5.1. Where a Club conducts single gender championships

- The Club Men's Singles Champion is eligible to enter the Men's Champion of Club Champions Singles.
- The Club Women's Singles Champion is eligible to enter the Women's Champion of Champions Singles.
- The Club Men's Pairs Champion is eligible to enter the Men's Champion of Club Champions Pairs.
- The Club Women's Pairs Champion is eligible to enter the Women's Champion of Champions Pairs.

5.2. Where a Club conducts only open gender championships

- If the current season Club Singles Champion is female, they are eligible to enter the Women's Champion of Champions Singles & the club will have no representative in the Men's Champion of Club Champions Singles.
- If the current season Club Singles Champion is male, they are eligible to enter the Men's Champion of Champions Singles & the club will have no representative in the Women's Champion of Club Champions Singles.

- If the current season Club Pairs Champion are both female, they are eligible to enter the Women's Champion of Champions Pairs & the club will have no representative in the Men's Champion of Club Champions Pairs.
- If the current season Club Pairs Champion are both male, they are eligible to enter the Men's Champion of Champions Pairs & the club will have no representative in the Women's Champion of Club Champions Pairs.
- If the current season Club Pairs Champion are one male and one female, they are ineligible to enter either Champion of Champions Pairs & the club will have no representative in Champion of Club Champions Pairs.

5.3. Where a Club Conducts both single and open gender championships

• If a club conducts both single and open gender championships, the single gender champion shall be the one eligible to enter the Champion of Club Champions

6. Entry

Club Champions will enter directly to State Finals with Bowls NSW.

7. Substitutes & Replacement Players

7.1. Replacement Players

Replacement players are not permitted.

7.2. Substitutes

A substitute will be permitted in Pairs (as an affiliated member substitute)

The player acting as a substitute must have been eligible to enter the Club Pairs and not have been constituted in that competition.

8. Entry Fee

As determined by the Board of Bowls NSW.

9. Competition format

Competition will be conducted as a combination of sectional play and knockout.
