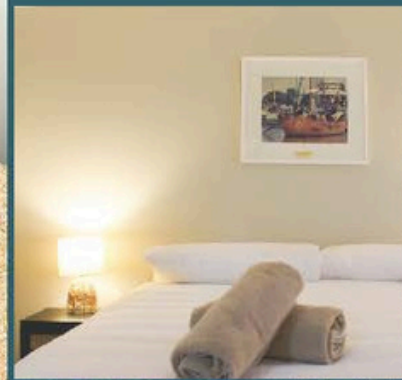

## Conditions of Play

### Controlling Body

The State Match Committee is the Controlling Body.

### Number of Bowls & Duration of Matches

3 Bowls per player.

Duration of matches shall be 18 ends.

Each match shall be limited to 2 hours and 15 minutes.

A signal will be given to commence matches. When the time limit is reached a signal will be given that the time limit has been reached. At the conclusion of the time limit any end in progress shall be completed, but no further ends commenced.

### Trial Ends

There will be 1 trial end prior to any match.

### Determination of Section Winners

In each match of sectional play, points shall be awarded as follows: Win: 3 points, Draw: 1 Point, Loss: 0 Points.

The winner of the sectional series of matches shall be determined as follows:

- The player/team scoring the highest number of points shall be declared the winner.

- If two or more players/teams are equal on points, the side with the largest difference between total shots for and total shots against shall be the winner.

- If there is still a tie, the player/team with the lowest total shots against shall be the winner.

- If there is still a tie, the player/team winning the highest number of ends over all games in sectional play shall be declared the winner.

### Post sectional Play

The winner of each section shall play quarter-finals:

QF#1: winner of section 1 v winner of section 2

QF#2: winner of section 3 v winner of section 4

QF#3: winner of section 5 v winner of section 6

QF#4: winner of section 7 v winner of section 8.

The winners of the quarter-finals shall play semi-finals:

SF#A: winner of QF#1 v winner of QF#2

SF#B: winner of QF#3 v winner of QF#4

In each post -sectional match the player/team scoring the higher aggregate number of shots shall be declared the winner.

If at the completion of the scheduled number of ends scores are tied, an extra end or ends shall be played to determine a result.

### Variations to the Conditions of Play

The Controlling Body shall have the authority to vary the Conditions of Play to bring the Championships to a successful conclusion.
