












































































### Bowls NSW Member Conference & Partner Expo

# State Umpires Committee Keeping things Crystal Clear

In the game of bowls situations arise which for some bowlers, they are silly and yet for other bowlers it concerns them. Below are two actual incidents that did occur.

1. Before the start of a Club Championship the participants had a two end roll up. On the first end the lead placed the mat on the centre line and delivered the jack, which rolled into the ditch. The umpire instructed the skip to roll the jack back. The umpire was told by the players that it is a trial end. The umpire stated that it does not matter, you need to roll the jack back. Was the umpire correct?

#### Laws:

#### Law 5.1 Trial ends:

**5.1.7** The team which starts the trial end must place the mat, deliver the jack and place the jack on the centre line of the rink at a distance they choose from the mat line (the distance must not be changed during the course of the trial end).

#### Law 10 Improper delivery of the jack

**10.2** If a player improperly delivers the jack, the opposing player must place the mat as described in **law 6.1.1** and re-deliver the jack, making sure that it is centred, but the opposing player must not play first.

#### Summary:

Improper delivery of a jack is only relevant in any end during a game. The trial end is not included as part of the game. The umpire was incorrect in their decision as it was only a Trial End.

For the situation described above, **law 5.1.7** would be the relevant law:



The team which starts the trial end must place the mat, deliver the jack and place the jack on the centre line of the rink at a distance they choose from the mat line (the distance must not be changed during the course of the trial end).

Therefore, the skip of the lead that delivered the jack would need to retrieve the jack from the ditch and place the jack on the centre line at a distance they choose from the mat line, as per law 5.1.7, and the trial end would continue.

2. During a District triples game both leads were asked to do the measuring as the seconds could not. The two skips were told, and they were required to measure a few times with no problems. However, there was a very close measure and one of the leads called the umpire, the opposing skip came down and said she had no right to call the umpie as only the second can. The umpire became involved and also said they couldn't call the umpire only the second.

#### Summary:

As there is nothing in the Laws of the Sport of Bowls nor the 2024-25 Bowls NSW Conditions of Play, that states the members of a team who are assigned to measure for shot, must inform the Seconds or indeed the Skips before they summon the Umpire to decide which bowl is shot. So technically both Leads were not in breach of any law.

As the Seconds are the members of a team in Triples who are assigned to decide the head, ethically the Leads should have informed the Seconds of the situation with the measure, and that an Umpire is required to measure and decide the result.

The situation could have been avoided if the Leads were informed of their responsibilities when they were assigned the task of measuring and what they must do if an Umpire is required. I also recommend that the duties of a member in a team (a Lead in Triples and a Lead or Second in Fours) who is assigned to measure, in place of the second in Triples and the thirds in Fours, in a game are publicised and given to the members and/or placed on your Club noticeboard. This may help to avoid this situation in the future.
