# **CONDITIONS OF PLAY**

#### **Controlling Body**

The State Match Committee is the Controlling Body.

#### **Duration of Matches**

Each match shall comprise of 63 ends (21 ends per rink). Dead ends shall be replayed.

#### **Trial Ends**

Two (2) trial ends shall be permitted at the commencement of each match.

#### **Play Not Completed**

If a match is not able to be completed (63 completed ends), a minimum of 54 completed ends shall constitute a completed match.

#### **Point Scoring**

In each match of sectional play points shall be awarded as follows: *Side Win:* 7 points *Team Win:* 1 point *Side Draw:* 3.5 points *Team Draw:* 0.5 points *Side Loss:* 0 points *Team Loss:* 0 points *Total Points per Match:* 10 points

#### **Determining Section Rankings**

Sides shall be ranked within their section by the following criteria: i. The Side scoring the highest number of

**ii.** The side with the largest difference

between 'total shots for' and 'total shots against'.

**iii.** The lowest 'total shots against' shall be the winner.

iv. The aggregate results from matches played between the equal sides using (i.), (ii.), (iii.) above (in that order).

#### Sides:

Sides consist of three teams of four players. In all matches the draw will be Team 1 v Team 1, Team 2 v Team 2 and Team 3 v Team 3.

Any side changes must be nominated to Venue Controller.

Note: The team draw will be changed if Sides from the same section subsequently play against each other in post-sectional play.

#### **Post Sectional Play**

The highest placed two sides in each section will qualify for Quarter Finals. QF1: Winner Section 1 v 2nd Section 2 QF2: Winner Section 2 v 2nd Section 1 QF3: Winner Section 3 v 2nd Section 4 QF4: Winner Section 4 v 2nd Section 3 SF1: Winner QF1 v Winner QF2 SF2: Winner QF3 v Winner QF4 Final: Winner SF1 v Winner SF2

In Post Sectional Play, the side scoring the highest aggregate number of shots shall be the winner.

If scores are tied after 63 ends, each team shall play an extra end to determine the winner. If Side scores are tied after the extra end a further extra end (or ends) shall be played as necessary to determine a winner.

#### Variations to the Conditions of Play

The Controlling Body shall have the authority to vary the Conditions of Play to bring the event to a successful conclusion.


